LOCATION: GRANVILLE STP SCRP (13): BEGINNING IN THE TOWN OF GRANVILLE ON VT ROUTE 100 AT STATION 400+25.00 (MM 7.580), AND EXTENDING NORTHERLY APPROXIMATELY 75.00 FEET (0.014 MILES) TO STATION 401+00.00 (MM 7.595).

TYPE OF CONSTRUCTION: WORK TO BE PERFORMED UNDER THIS PROJECT INCLUDES THE REMOVAL OF THE EXISTING PIPE CULVERT, INSTALLATION OF A PRECAST CONCRETE BOX CULVERT, AND OTHER HIGHWAY RELATED ITEMS.
