

List of Prequalified Consultant Appraisers

The State of Vermont Agency of Transportation (abbreviated VTrans) hires only the prequalified consultant real estate appraisers who are contained within the pages to follow. The Code of Federal Regulations Title 49 Part 24 Section 103(d) (abbreviated CFR 49 24.103(d)) requires VTrans to establish criteria for determining the minimum qualifications and competency of appraisers and review appraisers. These qualifications and criteria are described in the VTrans Right of Way Manual, which incorporates by reference State of Vermont, and Federal law and guidelines. When Federal funds are used, these prequalified appraisers must be the sole author(s) of appraisal reports that are submitted to VTrans.

No persons other than the sole author of the appraisal report may provide professional assistance without prior written approval from the VTrans ROW Appraisal Chief or VTrans Review Appraiser.

Prior to a prequalified appraiser accepting an assignment, it is required that the appraiser discuss the scope of work with the VTrans Right of Way Appraisal Chief or VTrans Review Appraiser. This will save all parties time and resources.

Applicants to this list should consult the Right of Way Appraisal Chief.
