### National Environmental Policy Act (NEPA)

- Federal Law that requires federal agencies to assess the environmental impacts of their proposed actions prior to undertaking major federal actions
- Levels of NEPA environmental review
  - Categorical Exclusion (CE)
  - Environmental Assessment (EA)
  - Environmental Impact Statement (EIS)



# **Project Environmental Permitting**

- Separate from NEPA Process
- Permits/Resource coordination underway
  - US Army Corps of Engineers
  - US Fish & Wildlife Service
  - Vermont ANR/DEC
- Timeline is partially concurrent with EA process



## **Changes to NEPA Environmental Review**

- Original NEPA review was a CE
- Requirement to re-evaluate the NEPA document
- Elevate the review to an EA
- EA evaluations are currently underway by resource professionals

- Draft EA
- 30-day public review and comment period
- Public hearing
- Response to comments
- Final draft EA
- FHWA determination



#### **Purpose and Need**

- Replace bridges on Main Street and Merchants Row
- Reconstruct rail through the project area
- Address existing drainage concerns of the rail line

- Floodplains and floodways
- Wildlife

- Complete draft environmental assessment document: **April 2017**
- 30-day public review and comment period: May 2017
- Public hearing: May 2017
- Response to comments: June 2017
- Final draft environmental assessment document: June 2017
- FHWA determination: August 2017

### **Bridge Maintenance Issues**

- Safety concerns for both Main Street and Merchants Row
- Temporary patching on both bridges
- Debris on railroad tracks
- Evaluating further actions





#### **Current Project Cost Estimate**

- Preliminary Engineering \$4,875,000
- Right-of-Way \$400,000
- Construction
  - Contract 1 (drainage) \$2,500,000
  - Contract 2 (bridge replacement) \$37,500,000



### **Independent Cost Estimating**

#### Estimate may be adjusted

- Independent cost estimate is in progress
- Look for cost savings due to accelerated bridge construction
- CMGC process will look for efficiency and cost savings
- Preliminary work by independent cost estimator validates the \$40 million construction





#### **Railroad Detour Costs**

- Very preliminary estimate \$12,000,000
  - Extended work windows in year 2 and year 3
  - 10 week train detour
- Capital track and facility improvements
- Reimbursement for RR costs incurred
- ICE estimates without RR accommodations construction cost would be \$82,000,0000



### **Project Timeline Update**

- Schedule was previously presented as 2017–2020
- Current schedule dependent on NEPA process outcome
- Revised target schedule 2018–2021
